Position: Project Coordinator, Human-Wildlife Conflict Mitigation - Andaman Islands

Number of vacancies: One

Duration: Long-term position (3 years with 3 months probationary period)

Position details: The Project Coordinator will be in charge of reporting, monitoring and overseeing timely delivery of project deliverables for the human-salt water crocodile conflict mitigation project in the Andaman islands. This is a mid-management level, site-embedded position, and candidates are expected to have excellent coordination, communication, project management and networking skills.

Primary responsibilities:

The primary responsibilities of this position include:

1. Coordinating, planning and executing project activities related to human-crocodile conflict mitigation, wet waste management and livelihood generation in the Andaman islands.
2. Keeping track of project timelines, managing budget, monthly donor reporting, and monitoring & evaluation of the project
3. Advising, mentoring and supporting the project team for implementing the field interventions.
4. Liaising with project partners like the Forest Department, Rural Development Department and District administration for the project execution.

Candidates with the following basic qualifications/skills will be preferred:

1. A master's degree with a minimum of **six years** or a bachelor's degree with a **minimum of 8 years** of work experience in project management in the development/environment sector.
2. Fluency in English (spoken and written) and Hindi (spoken).
3. Demonstrable ability to think independently, supervise teams and field activities, meet deadlines, track deliverables, organise meetings and undertake coordination of field logistics.
4. Experience of donor coordination and management of large scale projects.
5. Proven ability to work in collaboration with diverse stakeholders and teams, including government departments and institutions.
6. Ability and commitment to working with rural, marginalised communities
7. Proven ability to stay in a rural field site for an extended duration. Please note that this position requires the candidate to be based in Andamans site, for at least 9 months of the year.

Remuneration: Remuneration will be commensurate with qualifications and work, in line with our internal

policy. Candidates shortlisted for the interview will be given further details on the salary ranges to review.
